In the current time of austerity, migration has been put at the forefront of many debates surrounding public spending. Nationalist and populist arguments are increasingly capitalising on the idea that immigration is adding further strains on scarce resources and are deeply undermining attempts at social inclusion and social cohesion.

Reflections that go beyond divisive nationalist arguments are rare despite the fact that the enforcement of austerity policies affect not only migrant workers and other vulnerable groups but a growing part of the working national population.

This workshop aims to contribute to the public debate on immigration, the labour market and political regulations by comparing and contrasting alternative views to the mainstream standpoints and by providing an informed outlook on current challenges as well as a reflection on possible solutions.

The workshop will:

- consider the working and living conditions of migrant workers in the UK
- analyse the effects of austerity measures on BME communities
- scrutinise the policies advocated by political parties
- reflect on the challenges for, and the role of, trade unions in promoting social cohesion

The contribution of international speakers will provide a comparative view on these topics and will enlarge the debate about the impact of neoliberalism, austerity and economic crisis on the labour standards and national regulatory frameworks.
