Erasmus University Rotterdam, The Netherlands. Erasmus University Rotterdam (EUR) is an internationally oriented research university with a strong social orientation in its teaching and research. 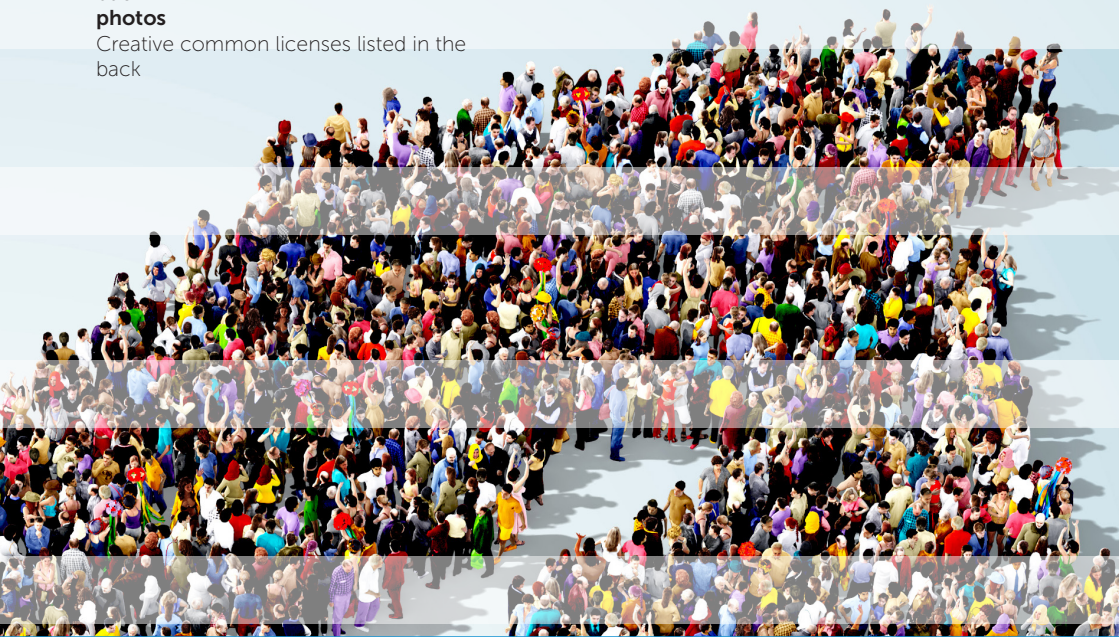

Keynote speaker:

“Understanding urban diversity, or what’s the matter with Rotterdam?”

Following a brief discussion of various ways ‘urban diversity’ has been conceived and discussed in assorted social science literatures, I will focus on some key questions concerning the relations between urban space(s), difference, ‘contact’ and social attitudes. This will include a look at places where high levels of ‘diversity’ have not produced the modes of cosmopolitanism that many have come to expect. In so doing, I will also address social effects of diversification processes themselves.

Steven Vertovec is Managing Director at the Max-Planck Institute for the Study of Religious and Ethnic Diversity, Göttingen. Previously he was Professor of Transnational Anthropology at the University of Oxford, Director of the Centre on Migration, Policy and Society (COMPAS) and Co-Director of the International Migration Institute (IMI).

Steve is currently co-Editor of the journal *Global Networks* and Editor of the

Palgrave book series ‘Global Diversities’. He is author of five books including *Transnationalism* (Routledge, 2009) and *Diversity and Contact* (Palgrave 2016), and is editor or co-editor of thirty-five volumes including *Conceiving Cosmopolitanism* (Oxford University Press, 2003), *The Multicultural Backlash* (Routledge 2010), *The International Handbook of Diversity Studies* (Routledge 2015) and *Diversities Old and New* (Palgrave, 2015).

The Winner of the IMISCOE Maria Ioannis Baganha Dissertation Award 2017 is: Dr. Yossi Harpaz

His dissertation entitled "Compensatory Citizenship: A Comparative Study of Dual Nationality in Serbia, Mexico and Israel", was defended at Princeton University in September 2016.

The award ceremony will take place during the IMISCOE conference in Rotterdam, on Wednesday June 28th 2017.

Dr. Harpaz's thesis is an extremely original piece of work which makes a highly innovative shift from the dominant focus on dual citizenship. According to the author, since the 1990's there has been a transformation of the meaning of citizenship "from an ascribed, rigid category that one is born into and has little prospect of changing, into a flexible status that one may pick and choose – or even strategize to maximize utility and compete with other actors." In other words, as one reviewer puts it, citizenship has been

commodified. But this occurs in a context in which citizenship is globally stratified which alters the conceptual concerns to global inequality, leading to a consideration of the comparative value of different citizenships. The central notion of asymmetric forms of citizenship emerges from the observed value of different citizenships and therefore the desirability of acquiring 'compensatory citizenship' -a concept the author develops- for those whose citizenship is of limited global value but at the same time have a chance of accessing more valuable forms of citizenship. Once set out, the author pursues these ideas in his thesis through an original combination of methods (large scale statistical/demographic and small scale, detailed qualitative political) to elucidate both the overall impact of compensatory citizenship and explanations for the specific instances in which it is found. The three empirical case studies are well chosen and are richly supported based on an impressive body of original research. The reviewers are unanimous in considering that this thesis is both theoretically and methodologically innovative and is a work of high quality that deserves recognition at the highest level.

About the Maria Baganha Award

The IMISCOE Research Network has awarded the Maria Ioannis Baganha Distinguished Dissertation Award annually since 2010 to stimulate and recognise excellent PhD research in the field of migration, integration and social cohesion in Europe. The competition is open to all PhD recipients whose dissertations were defended within the 24-month period before the submission deadline (early February each year). Applicants are invited to apply on their own behalf, or may be nominated by their dissertation supervisors.

Keynote lecture 2 : 15:45, 30 June 2017

“When cities become the last refuge for the displaced”

The paper examines three emergent migration flows, each with specific features that can be described as extreme. Two are familiar and have generated recognized subjects: the immigrant and the refugee. I focus on a third emergent subject: a refugee of a massive loss of habitat, largely due to particular forms of economic development that cause environmental destruction. The effort organizing the paper is to understand conditions at places of origin that lead people to risk their lives in dangerous trips to escape those places of origin. As is by now known, these migrants are not the poorest of the poor in their places of origins. The rapid surge in these flows combined with the conditions they leave behind raise a question that organizes much of the analysis: Are the categories we use to understand and describe migrations—that is, the notion of people in search of a better life, who leave behind a family and home that they want to support from afar and possibly return to—enough to capture the specificity of these emergent flows. My answer is: not quite.

Saskia Sassen is the Robert S. Lynd Professor of Sociology and Member of The Committee on Global Thought, Columbia University (www.saskiasassen.com). Her latest book is *Expulsions: Brutality and Complexity in the Global Economy* (Harvard University Press 2014) now out in 15 languages, including Dutch with ACCO. She is the recipient of diverse awards, including multiple doctor honoris causa, the Principe de Asturias 2013 Prize in the Social Sciences, and made a Foreign Member of the Royal Academy of the Sciences of Netherland.

Migration research, cities and urban governance

Over the past 20 years or so, the role of cities in the governance of migration and integration has increasingly been recognized. This recognition of the role of cities in governing migration, and conversely, of the importance of migration and diversity as an issue for urban governance has not only given rise to an increasing number of studies focusing on the local level but also translated into the identification of migration as a key policy concern by urban policy makers, city networks, and supra- and international actors. As a corollary, there are increasing efforts in both knowledge production and knowledge transfer on local aspects of migration and integration that respond to the need of urban policy makers, reflected, amongst others, in the growing importance of cities as funders of

research or the establishment of a variety of transnational initiatives focusing on migration and integration at the city level, often involving established city networks, with a prominent role of lead cities.

This semi-plenary focuses on the role of academic knowledge production for local level governance of migration, the ability of city stakeholders in shaping research agendas, and conversely, the role of researchers in informing policy agendas on the local level. How do cities mobilise knowledge through funding research or participation in relevant networks and initiatives? What kind of knowledge is available or required to meet cities' needs? Are cities able to mobilise the expertise required through own means? To what extent can cities benefit from national and supranational research and knowledge exchange programmes? How are research findings translated into practical knowledge? What capacities are required both on the side of research and city administrations? Can smaller cities equally mobilise and absorb relevant expertise? What are the risks and benefits in addressing a wide range of traditional policy fields such as housing, welfare, employment, provision of services or specific challenges such as poverty, homelessness, or begging as a challenge of migration and integration? How are challenges specifically related to migration – such as the presence of irregular migrants, segregation, and radicalization addressed through expertise?

The Mediterranean lies at the heart of migration studies in Europe and currently it is a focal point of large-scale human displacement. This is a global challenge with major effects on origin and destination countries in terms of society and politics, and with important implications for border and diversity policies and geopolitical strategies.

The **2018 IMISCOE** Annual Conference in Barcelona aims to approach human mobilities as a reality and diversity as a resource and an opportunity to connect

societies and cities in Europe and the Mediterranean. The Conference will promote a dialogue between scholars and policy makers and to open a forum for methodological discussions linking Mediterranean and migration studies.

Specific study categories will be present during the sessions such as transnationalism, super-diversity, solidarity, diaspora and co-development, and to link these with broader principles on human rights, democracy and liberalism.

Conference Practicalities

How to get to Rotterdam by train

You will probably be arriving at an airport near Rotterdam (The Hague/Rotterdam airport) or Schiphol Airport (Amsterdam) before the conference. Here we will explain how to get to Rotterdam from the various airports by train. Schiphol is the largest airport in the Netherlands, yet it is also a hub in the Dutch rail network, making it relatively straightforward to get from there to anywhere else in the country. To get to Rotterdam, you can buy your transport card at one of the yellow ticket machines in the Schiphol Plaza. Here you can choose between the high-speed Intercity Direct, which requires an additional fee, and the basic Intercity trains. Always check in and out by swiping your card at the yellow card readers located at the top of the escalators and at the exit of the station where you will be arriving. Trains heading to Rotterdam usually depart from track 5 or 6 at Schiphol station.

If you are arriving at Eindhoven airport you first need to take the bus 400 or 401 (Hermes) to Eindhoven central station. From there you may take the Intercity train to Rotterdam. Again, you need to purchase a transport card at the yellow machines at the station before checking in via the card readers to embark on your journey. Alternatively, you may land at Brussel Airport – Zaventem. This airport is also directly connected to Rotterdam via the rail network. It is recommended to buy train tickets in advance on nsinternationaal.nl/en when travelling from Belgium. For more details on departure and arrival times and possible transits, you can plan your train journey online at ns.nl/en or 9292.nl/en, which will give you door-to-door travel advice and keep you updated on any delays or malfunctions.

Getting around in Rotterdam

When you've finally made it to Rotterdam you may wonder how to make your way to your hotel or the Erasmus University campus. If you plan to use the public transport to travel around the city, you will need a transport card. There is a variety of options to choose from, ranging from the 1 hour card (€ 3.00), the 2 hour card (€ 3.50), the 2x1 hour card (€ 6.00), to the day card (€ 7.50). Always remember to check in and out when you travel by public transport. This is done by simply swiping your card at the designated card readers. Be aware though – swipe your card before boarding the train or metro but after you have entered the tram or bus.

If you are travelling via metro, you will want to exit at station Kralingse Zoom to get to the Woudestein campus. Take the A, B, or C line in the direction of Binnenhof, Nesselande, or De Terp. After you have exited the metro you will have to walk for a few minutes to reach the campus grounds. Alternatively, you

can take tram 7, 21, or 24 in the direction of Woudestein or De Esch, exiting at the Woudestein stop next to the Excelsior football stadium. For more detailed information on getting to the IMISCOE Annual Conference location (Woudestein campus), you can visit www.eur.nl/english/guide/how_to_get_there/ to prepare your journey by bike, train, or car.

How to register

About the Erasmus University Rotterdam

The roots of the present-day Erasmus University Rotterdam go back to 1913, when the Dutch Trade School opened its doors in our bustling city. During previous years trade had flourished in the region, stimulating a growing demand for well-educated economists to work in the port of Rotterdam. In the following years this institution acquired a name for itself on the basis of its achievements in economic research and education, with the Nobel prize for Jan Tinbergen in 1969 as a particular highlight. Along the way the university has expanded this initial focus on economics to include other academic disciplines such as medicine, law, philosophy, sociology, and arts.

In 1968 this expansion, and the growing number of students it brought with it, led the university to move to the current Woudestein campus in the Kralingen area. Around the same time, in 1973, the university also adopted the name of one of the city's greatest thinkers – Desiderius Erasmus. At the start of the Renaissance the work of this renowned philosopher, theologian, and humanist had a profound influence on the cultural and intellectual climate in Europe. Today Erasmus' cosmopolitanism, pithily captured in his adage 'the entire world is my fatherland', is reflected by our university's international research projects and diverse student body.

As is so often the case in a modern and dynamic city such as Rotterdam, everything here seems to be swept up in a perpetual flow of change, which has not left our campus grounds untouched. While the matter-of-fact brutalism of its monumental core – the Theil, Erasmus, and Tinbergen buildings - is being restored to its former glory, the rest of the campus is taking a turn for the twenty-first century. New buildings have been added recently to meet the needs of a new generation of academics. These flexible structures and sustainable designs accommodate a variety of study areas and on-campus housing, animating the Woudestein campus and bringing the university closer to meeting its long-term energy neutrality goals.

The nccr – on the move at a Glance

The nccr – on the move is the National Center of Competence in Research (NCCR) for migration and mobility studies, financed by the Swiss National Science Foundation. Designed to develop new perspectives on changing migratory realities, the nccr – on the move brings together research projects from social sciences, economics and law – combined to address the overall research question: What is the character of contemporary migration and mobility patterns within the so-called Migration-Mobility Nexus?

Who We Are

Managed from the University of Neuchatel, the network consists of some 70 researchers from social sciences, economics and law at the universities of Neuchatel, Basel, Bern, Fribourg, Geneva, Lausanne, Lucerne, and Zurich.

Making Data Available

The nccr – on the move produces and disseminates data on migration and mobility. By linking information from different Swiss administrative registers, it is possible to reconstitute individual and households life trajectories. The center also produces original data: the Migration-Mobility Survey.

Advancing Young Researchers

The nccr – on the move fellows receive disciplinary and interdisciplinary training, amongst others a four-year doctoral program. The center is further committed to the advancement of young female researchers and has adopted a set of measures such as a peer-mentoring group and financial support grants. Moreover, the nccr – on the move encourages and supports visiting research stays in its partner universities.

Providing Platforms for Academic Exchange

A broad range of platforms for internal and external academic exchange allows for shedding light on the overarching topic of the Migration-Mobility Nexus. The nccr – on the move organizes the Neuchatel Graduate Conference of Migration and Mobility Studies as well as exchanges with leading academics in the form of public lectures. In addition, the nccr – on the move publishes a Working Paper Series.

Reaching out to a Broader Audience

The nccr – on the move enters into a dialogue with private and public audiences. Our blog deals with political issues and practical experiences. The Policy Briefs *in a nutshell* provide answers to topical questions and the online magazine *highlights* integrates different research findings by discussing one focus topic from several perspectives. Regularly, the nccr – on the move organizes expert exchange roundtables with stakeholders and decision makers.
